The following programme of activities have been lined up for 2001 :

1. Members Luncheon

Members Luncheon is a forum for the members to network with their peers and the club arranges two or three Members Luncheon in a year. The Club has approached a few organizations of interest to the members and you will be informed when final arrangements are made.

2. Anniversary Dinner

The Club was registered on 19 July 1977 and the 24th Anniversary Dinner will take place on 19 July 2001. As in the past, this will be a real social event so that members can relax and enjoy the programme for the evening.

3. Manager of the Year Award

The Manager of the Year Award is the Club's contribution towards encouraging and promoting excellence in professional business management in the country.

The award is given to the Chief Executive Officer of an organization who will be awarded a cash prize of RM10,000, a plaque and a certificate.

4. HBS Regional Conference/HBS Roundtable Conference

The Harvard Business School Alumni arranges Regional Conference all over the world such as in 1999, it was held in Capetown, South Africa and the 2000 Conference was held in Berlin.

The 2001 Conference will be held in Cleveland, U.S.A from 16-18 May 2001. The Conference enables the alumni from all over the world to meet and discuss matters of interest and listen to the Professors of HBS on latest topics.

5. Gold Medal/Scholarship Awards

3. HBSACM Invitation/Westport Open

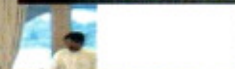

Gold Medal Award

A selection committee to select the best student evaluating the graduate's high performance during his university examinations, his extra mural activities in which he has taken part such as sports, participation as member of various committees in Colleges and University level, representing University in national/international level. The final selection is done by an interview with the graduates to test their application of their book knowledge to every day life. The Award consists of a Gold Medal, RM3,000 in cash and a Certificate.

Scholarship Award

The Foundation awards financial assistance to the eligible candidates to pursue their post graduate studies in local or foreign universities. The candidate must be a Malaysian Citizen and should have at least a Second Class Upper Honours degree from a recognized University or its equivalent. He/she must have been admitted for full-time studies leading to a Doctorate or Masters Degree in Business Studies in an approved institution of higher learning in the year of Scholarship. The Scholarship is tenable for 2 years. The candidate is required to sign a performance bond with the Club but is not however required to be otherwise bonded to work for the club or its sponsor.
