We will examine those countries most relevant to Malaysia: Singapore, China, India, Saudi Arabia and the United States, and we'll cap it off with a company that hopes to end climate change."

#### Richard Vietor:

Professor Vietor is a Baker Foundation Professor of Business Management who taught at the Harvard Graduate School of Business Administration in courses in energy, the environment and the international political economy. He received a B.A. in economics from Union College (1967), an M.A. in history from Hofstra University (1971), and a Ph.D. in history from the University of Pittsburgh (1975).

For his courses in business-government relations and environmental management, Professor Vietor has published more than one hundred and seventy (170) case studies and notes on energy practice and policy, government regulation and on the national development strategies of a dozen countries. He has been a consultant to the Hudson Institute and the Energy Research and Development Administration, serves on the Advisory Boards of IPADE (in Mexico), IESE (in Spain), INALDE (in Columbia), the Luigi Gerardo Napolitano Society (in Italy), and several firms. He has been a consultant to the Prime Minister of Malaysia.

The participation fee of RM 10,000 is inclusive of tuition, case materials, and meals.

All the past Programs are claimable under SBL Scheme. We are in the process of applying for similar approval from Pembangunan Sumber Manusia Berhad (HRDF).

The participants of the past Programs have awarded high rating for the Programs and the Professors concerned.

Upon completion of the Program, the participant will receive a certificate from the Guest-of-Honour at the Graduation Ceremony.
